General Membership Policies	For the safety of children and others, we ask parents to observe the
All members 10 years and older are required to present a valid membership card for identification when using Centre facilities and programs. If you do not have your membership card with you, you must present your driver's license or another form of picture ID. You are responsible for purchasing a new membership card should you lose yours. Membership privileges and cards are not transferable and remain the property of the New Richmond Area Centre, Ltd., and must be returned upon request. Membership in the New Richmond Area Centre, Ltd. continues on a month to month basis indefinitely until written notice of cancellation is provided by the member or by the Centre in accordance with its policies and procedures. I understand termination requires a 15 day notice prior to the draft date and must be submitted in person. The terms and conditions of membership are subject to change. I understand and agree that the New	Children 8 & 9 years old may be in the pool or building without direct supervision, but guardian must remain in the facility. Children 6 & 7 years old must have a guardian on pool deck and with them at all times in the facility. If guardian is not with them, children must be checked into Kids Kove. Children 5 and under must have a guardian in the pool with them within arm's reach and with them at all times in the facility. If guardian is not with them, children must be checked into Kids Kove. Children NOT potty trained must wear both a swim diaper AND plastic pants over the swim diaper. (Both are available for purchase at the Welcome Center.) Pool Use & Water Safety If you or any of your family suffer from respiratory allments, please limit your exposure to the indoor pool environment. Please limit your and your children's exposure to the hot tubs. Due to health and safety concerns children under 16 years of age are not permitted to use the hot tub unless prescribed by your physician. Repeated or extended exposure to chemically treated water may cause skin irritations to young children and to individuals with sensitive skin. Exposure to the outdoor elements combined with hot tub use is likely to cause skin irritations. This is most likely to occur in the colder months of the year or when skin is exposed to snow. The New Richmond Area Centre, Ltd. takes every precaution to ensure the safety of our guests and their families. The Centre staffs ample CPR trained lifeguards and strictly adheres to state standard for pool cleanliness, chemical levels, and safety. The Centre strongly urges small children to wear Coast Guard approved life jackets. A limited number of life jackets are available for your use. Please ask a lifeguard for one. Please observe pool rules and ALWAYS watch your children. In general, you should limit the time you or your children are exposed to the pool water and the indoor pool environment. Over exposure to the indoor pool environment and water may cause eye, throat and skin irritatio
